OFFICIAL RULES

- 2. <u>Eligibility</u>. - 3. <u>**How To Enter**</u>. The Sweepstakes will begin at 11:01 a.m. (E.T.) on Saturday August 24, 2019 and end at 1:59 p.m. (E.T.) on Saturday August 24, 2019 (the "Sweepstakes Period"). Sponsor will be the official timekeeper for the Sweepstakes.

Enter by going to Shaker's Hyundai, 674 Straits Turnpike, Watertown, CT during the contest period. The first ninety-nine (99) entrants to check in at the WPLR Table will first fill out an official contest form (form will require entrants to fill in their full name, address, town, zip code, phone number and date of birth) and then "roll the dice" for a chance to win the grand prize (s).

a. In the event that the Contestant rolls all seven (7) dice and seven (7) Winning Faces land facing upward, and Sponsor and the Contestant have complied with the terms herein, then SCA shall pay to Sponsor Prize Level A specified in the Schedule of Available Prizes below, subject to the Maximum Aggregate Liability and verification by SCA. In the event that the Contestant rolls all seven (7) dice and six (6) Winning Faces land facing upward, and Sponsor Prize Level B specified in the SCA shall pay to Sponsor Prize Level B specified in the SCA shall pay to Sponsor Prize Level B specified in the Schedule of Available Prizes below, subject to the Maximum Aggregate Liability and verification by SCA.

b. Each of the seven (7) dice will have only ONE Winning Face. The required Winning Face(s) for Prize Level A shall be as follows: S, H, A, K, E, R, S. The required Winning Face(s) for Prize Level B shall be as follows: S, H, A, K, E, R

c. Each die will measure 1" x 1" x 1".

d. The total number of attempts must not exceed: Ninety-nine (99)

e. The total number of dice to be rolled for each attempt shall be exactly seven (7). The dice must be simultaneously rolled. Each die must roll at least three (3) feet and must bounce against or directly hit the backboard of the playing surface in order to be considered an eligible roll. When the dice come to rest at the end of an attempt, each die must remain on the playing surface and with one face flat on the playing surface. Only the face that finally lands facing upward will be eligible for play.

f. From the moment the dice are given to the Contestant until the attempt is complete, the dice may not be interfered with in any way and may not touch anything other than the playing surface. If any die involved in an attempt does not roll at least three (3) feet, directly hit the backboard, or does not end up with one face flat on the playing surface or is otherwise leaning, the die will be considered ineligible and the contestant must roll only the ineligible die again. The die that has one face flat on the playing surface may be moved if necessary.

g. Sponsor must visually record each attempt. The visual recording must be time/date stamped, and all attempts must be recorded on the same visual recording. Sponsor must provide the visual recording to SCA, if requested, for claim verification purposes. The visual recording must clearly show each attempt such that the dice involved in the attempt are continuously visible from the moment they are given to the Contestant until the end of the attempt.
